Etlenne, May 12, 1842. He began writing music in his boyhood, when he entered the Paris Conservatory at the age of 11 years. His first serious work was done when he was 14 years

Those who had the pleasure of knowing the great French composer loved him. To the majority of them he was considered a man one felt better for knowing, although he of-ten insisted himself that he was a pessimist. On one occasion he told a visitor that he never went to hear one of his operas unless he was com

d pelled to.

The great operas that came from the pen of Massenet, who was a man of medium height, with dark hair and brilliant brown eyes, and unsually nervous, were written while the composer puffed on black cigars. He once said smoking was the only pleasure he got out of life. He was not a society man and refused invitations to many of the social affairs of Paris and other French cities.

From the time he won the Gand Prix de Rome in 1863 with the cantata "David Rizzio" until his death Massenet was one of the most prolific composers of his



#### THE SEVEN WHO WERE ELECTROCUTED

As might be expected, the spectacle of seven men going to death the other day in the electric chair at Sing Sing has renewedspasmodically at least-the old, old agitation for the abolition of capital punishment.

We incline strongly to the opinion, however, that the success of this agitation is practically hopeless until we understand and publicly recognize the fundamental reason why capital punishment

If we could, without taking a poll, enumerate the number of people strongly opposed to capital punishment, we should no doubt find that they largely exceed those who as strenuously advocate it. It goes without saying, of course, in this connection, that by far the greatest portion of the population are not sufficiently interested to earnestly advocate either the maintenance of capital punishment or its abolition. They may have what they call an opinion, but they would not take any particular trouble to have it enforced one or the other. And it is this indifference that largely accounts for the perpetuation of the taking of human life by the State in this manner. Indifference gives consent, so to speak.

At the Sing Sing butchery, it is safe to say, that not a single spectator, or even those who took part in the horrible work, approved of the task. The Sheriff himself, who supervised the job, and declared it successful, is, as he publicly announces, opposed to capital punishment on principle. The head warden, too, it seems, entertains similar views. Prominent men and women all over the country are at present denouncing the affair as "legalized murder" and are meeting no apparent opposition to their views. Congressmen, Senators, reformers, clergymen, and even lawyers, express themselves similarly. But capital punishment persists. Why: For what reason? There must be a reason—a fundamental, underlying reason.

And stripping away all the legal mummery about the majesty of the law, eye for an eye and tooth for a tooth, safeguarding society, punishment not for revenge but as a deterrent, and all the rest of the humbug under which we seek to conceal from ourselves the real reason, we shall find that the existence and perpetuation of capital punishment is based principally on the existence of a fundamental social condition.

And that condition is-poverty.

Poverty is the cause of capital punishment.

In the last analysis the wretches who went to the death chair in Sing Sing the other day were sent there not so much because they committed murder as because they were poor.

And because that idea is hateful we either deny it or conceal it from ourselves by inventing other and superficial reasons. We hate to really admit that poverty is regarded as a crime, or if we do admit it we merely "deplore," and let it go at that.

Does anybody believe that if any of those men executed the other day at Sing Sing had a million dollars he would have gone to the electric chair? Nobody, unless he is either blind or an idiot.

The five Italians were laborers, as were the remaining two. They were ignorant, bestial, cruel, vindictive, covetous, drunken and more or less insane. But they were all these things mainly because they were poor; because society had used them as beasts they were beasts. And they received the punishment inflicted on

They were at least as insane or of as low mentality as Thaw but that did not save them from the electric chair. But Thaw had millions of dollars, and they saved him. He wasn't poor, therefore he didn't die, though he killed with his own hand, in the presence of hundreds of witnesses, a person rated as infinitely more important, wealthy, powerful and influential than the victim for whom the the Italians were taken. Had Thaw merely killed a poor man, like, say, one of these Italian laborers, he would almost certainly have gone free.

Will all those implicated in the Rosenthal murder go to the death chair? Right now we say they will not. Not even if found guilty. There are big funds for their defense. There are seven of them also, but there will be no seven of them killed in a bunch. Those who died had no funds. They were poor; they had neither money nor the influence to procure money. And they paid for their poverty with their lives.

Why is a hobo or tramp run in on sight? Because he has "no visible means of support," the law specifically says. That is, in ordinary language, because he is poor

Will any one send us here the name of a multimillionaire who ever suffered the extreme penalty of the law? Or a common millionaire, or even a semi-millionaire or a demi-semi-millionaire? There may be such, but they are as scarce as hen's teeth. We can find a thousand poor men who have suffered capital punishment for every rich man who can be named.

If we want to abolish capital punishment, the way to go about it is to abolish poverty first.

The Socialist understands this, and that is the reason why demand for the abolition of capital punishment appears in Socialist platforms. But the Socialist is logical in his demand, for he also

demands the abolition of poverty as a precedent to the other.

Let us get rid of poverty, and capital punishment will die a natural death. When the prime cause is taken away the result will farmer slumbers, why should he hestdisappear also. Let us have no "poor," as we now know them, and we shall have neither jails nor electric chairs nor gallows trees. Let us have social justice and we shall have no place for the abomination that parades as "justice" today.

Horse, foot and artillery, all complete. Now all that is needed is an aeroplane service, and that will doubtless be added in due time.
